USAID Boresha Jamii is a PEPFAR-funded project through the United States Agency for International Devolvement (USAID) implemented by the Jaramogi Oginga Odinga University of Science and Technology (JOOUST) as its Prime with PATH Kenya and SCORE Kenya as its Sub Awardees. The project also works with four local implementing partners. The project is implemented in the counties of Kakamega, Kisumu, Vihiga and Nyamira.

The aim of the program is to provide integrated activities to achieve the Kenya Health Partnerships for Quality Services (KHPQS) goal and objectives, building on USAID's investment in health systems strengthening and FP/RMNCAH/WASH and Nutrition through supporting the Ministry of Health in achieving journey to self-reliance (J2SR) in Cluster 5 Counties of Western Kenya Region. The focus is to increase the use of Quality County led health and social services in the following programmatic areas; HIV care and treatment, Family Planning, Reproductive Health, Maternal, Neonatal, Child and Adolescent Health and Nutrition (FP/RHMNCAH), Water and Sanitation (WASH), and mitigating social determinants that affect Orphans and Vulnerable Children (OVC), Key and Priority Population (KP/PP) and Voluntary Medical Male Circumcision (VMMC).

Job description

Reporting to the County RMNCAH Coordinators; the incumbent will among others be responsible for the following;

The FP/RMNCAH Program Officers, will coordinate and oversee the FP/RMNCAH component of the Boresha Jamii Project in the sub counties of Kakamega and Kisumu, including providing technical, programmatic and operational support in strengthening integration of Family Planning, Maternal and Newborn Health, Child and AdolescentHealth services, and Gender Based Violence services in the Health System, and provide substantive support towards data collation and analysis. The Officers will be expected to support the SCHMT in the review, adaptation and development of evidence-based training materials, job aids, service delivery guidelines, quality improvement mechanisms, and other tools needed for the implementation of FP/RMNCAH activities in the context of the COVID 19 pandemic. She/he will also support the strengthening/ establishment of Sub County Integrated

RMNCAH, HIV, Nutrition and WASH technical working group to ensure that key RMNCAH interventions and strategies are integrated into the health policy and implementation aligns with the national RMNCAH investment case.

Minimum Job Requirements

- Diploma in Nursing or Clinical Medicine is required. Bachelor's Degree in a relevant field will be an added advantage.
- At least five (5) years of practical experience in planning, implementation, monitoring and supervision of maternal, neonatal, child and adolescent health activities including Family Planning at the County level including working with an integrated multi-sectoral TWG is preferred.
- Experience in implementation of SGBV initiatives is desired.
- Experience working with county government is most desirable.

Language Proficiency:

- Desired fluency in English, proven ability to communicate efficiently and concisely both orally and in writing.
- Should exhibit ability to produce professional quality technical and analytic materials, including program reports.

Job Knowledge: A broad knowledge of Family Planning, Maternal and Newborn Health, Child and Adolescent Health is required. Must have knowledge of the Kenyan Health Systems.

Skills and Abilities:

- The applicant must have excellent analytical and communication skills.
- Should demonstrate ability to establish and maintain relationships across government entities, donor organizations, and private-sector organizations.
- Exhibit the ability to obtain, evaluate and interpret factual data and prepare precise, accurate and complete reports is required.
